COVID-19 VACCINATION INFORMATION & DATA UPDATE

The Barren River District Health Department has confirmed a total of 30,264 cases, 27,580 of which have recovered. We have 423 deaths reported from COVID-19. We stand in solidarity with those affected during these difficult times. See the breakdown of numbers by county below. Please note that a decrease in numbers is due to the county of residence or case status being corrected/updated from what was previously reported.

- Enter first and last name, then enter a password and click Submit.
- Next, enter your cell phone number and click Submit. You will receive a passcode on your cell phone, enter that passcode on the website and click Submit.
- Finally, click Confirm Booking and you are all set!
